I Introduction

A reference can be cited as a parenthetical remark such that the author's name is not included directly in the prose (Thaer 1942). Alternatively, a source can be cited as a noun in the sentence, such as when the work of Thaer (1942) compels us to cite him. For such circumstances, footnotes are not necessary.¹

The *Taisei Sankei* 大成算経 is a 20 volume text composed by Seki Takakazu 関孝和 (? – 1708), Takebe Kataakira 建部賢明 (1661 – 1716), and Takebe Katahiro 建部賢弘 (1664 – 1739).
